To whomsoever concerned -

I am writing this letter to support my application for Lebanon Visitor Visa and have enclosed the required documentation. Please review all the details below which I hope would suffice to grant a Single-entry visitor Visa. The first section in this page contains details of my education and background profile followed by my financials, my investments / Bank accounts in India.

Please note that the bank statement I have enclosed with my application is from **Siam Commercial Bank in Thailand** as I used to work in Thailand from 2017 September until February 2022 when I decided to take an indefinite break from employment to pursue my travel interests.

I have savings of **Thai Baht 4,847,433** which is equivalent to **223,513,620 Lebanese pounds** which should be more than sufficient for 2 weeks of travel plans in Lebanon.

- I've a Bachelors of Engineering degree in Electrical and Electronics Engineering from Chennai, Tamil Nadu, **Timeframe:** 2001 - 2005
- I completed my Masters in Industrial Engineering from University of Texas at Arlington, **Timeframe:** 2006 August to 2007 December
- Employed with Sienna Corporation at Santa Clara, California from *March 2008 to May 2008*
- Employed with Sienna Corporation at Lisle, Illinois from *June 2008 to August 2011*
 - ★ *Decided to voluntarily move back to India in August 2011 for being closer to family and got married in December 2011, Divorced in 2019 November*
- Employed with Sienna Ecad Technologies Pvt Ltd in India (Bangalore) from 1st October 2016 to 31st July 2016
- Employed with Avalon Technology and Services Private Limited in India (Chennai) from 1st August 2016 to 30th Jun 2017
- Employed with Fabrinet Co. Ltd from Sep 2017 to March 2022 at Thailand (*My savings are with the **Siam Commercial Bank in Thailand**. I've included copy of my bank statement from Thailand as I have not moved my savings money from Thailand to India which is because I may go back to work in Thailand in Q1'2023 around March 2023*).

I have taken an indefinite break from employment to pursue my travel interests in 2022 (*Copy of certification from my last employer Fabrinet Co. Ltd indicating the same is enclosed*)

The Original Bank Certified copy of my savings as on October 11th is enclosed with my application. The Electronic copy of bank statement enclosed will show the transactions from October 2022 to January 2023.

Economic Status / Documents Enclosed with my application

- 1) I have Savings in Thailand Siam Commercial Bank Account Number 3702514214 – Lebanese pounds 223,513,620 (4,847,433 THB)
- 2) **Investments in India**
 - a. ICICI Prudential Mutual Fund Folio Number 6169740 / 29 in couple of different schemes. Latest statement dated July 6th is enclosed with my application. Cost of investment is Rs. 731,000 and current market value is at Rs. 1,351,128.23
 - b. ICICI Prudential life insurance Policy Number 17617019, Premium paid until now Rs. 350,000 and the sum assured when the policy matures 22nd March 2028 cannot be ascertained at this time.
- 3) Copy of my Aadhaar Card 8434 7888 0758
- 4) Copy of my PAN Card AYNPA4921B

Countries visited in 2022

- **Mar 4th** - Last day with my previous employer (Resignation date), I traveled to Nepal on Mar 5th to hike the Everest region, Annapurna region and was there until May 3rd 2022.
- **May 3rd** - I went to India and was there until May 18th just to meet family, friends and take care of some dental issues.
- **May 18th** - I left India and reached Thailand on a tourist visa to apply for Schengen Visa as my savings are in Thailand due to which I had to visit Thailand to get the original bank statement for submitting my application Europe. Prior to this, I had already got a visa to visit UK. Copy of both my Schengen Visa and UK Visa is enclosed.
- My Schengen Visa was issued by the Italian Embassy on Jun 6th 2022 and is valid from July 12th to October 24th as I had requested Visa only for this period since I need to travel to Australia by middle of October, copy of my visa is enclosed.
- **Jun 26th** - I left Thailand and reached UK to watch Wimbledon Tennis championship and some cricket.
- **July 18th** - I visited Sardinia, Italy to visit friends and then visit other regions of Italy for the next 3 weeks.
- August / September timeframe - I completed a hike from Chamonix, France to Zermatt, Switzerland and then traveled to some of the Nordic region - Helsinki, Tallinn, Riga, Vilnius, Krakow, Prague and finally ended my Eurotrip at Munich
- After my travel in Europe, I visited Thailand for a short period before heading to Vietnam and then to Australia for watching the T20 Cricket World cup.
- After the World Cup, I visited New Zealand for 18 days and then returned to Thailand, Laos and returned home to India on Jan 10th

Plans for Employment / Future Job prospects

- As I have detailed above in the first page detailing my profile and background, I have a Bachelors and Masters Degree along with 16 years of experience in the manufacturing Industry in various roles. I used to work in US and voluntarily moved out in 2011 as I wanted to stay closer to family. I accepted the job offer at Thailand as it is only a 3-hour flight away from home - Chennai, India.
- As discussed with my previous employer in Thailand, I am taking an indefinite break from work as I was employed as a Materials Program Manager and was in the middle of the Semiconductor crisis that has affected several industries across the globe. The job was very stressful and it is at this point I decided to take a break as I've never had a long break ever in my life. So, as I am approaching my 40 in 2023, I wanted to take a break in 2022 and resume employment early 2023 (Tentatively around March 2023)
- As far as my job prospects are concerned, I have already finished interview with Tesla and currently waiting for the final offer from them and should start working with them around March 2023. I have not yet moved my money / savings out of Thailand as I will go back to live there. I am also sharing my linkedin profile below which I have not updated but for the purpose of this application, it should suffice.
